### BACKGROUND:

The Canadian Aboriginal and Minority Supplier Council (CAMSC) was launched in Toronto on October 12, 2004 with assistance from the National Minority Supplier Development Council (NMSDC) and a group of Canadian and American corporations.

CAMSC and NMSDC enjoy a close working relationship and have agreed to recognize each other's certified minority suppliers and to make them available to their respective corporate members. Both organizations utilize identical certification processes and operational methodology.

### MISSION

Deliver programs and processes to promote and facilitate procurement opportunities between major corporations in Canada and suppliers of all sizes; owned and operated by Canadian Aboriginals and Visible Minorities.
